## 4. Legal benefit

As a trade union in the policing sector, the core of our services is to ensure that our members' interests in the workplace are completely safeguarded, hence our members will in addition to the abovementioned benefits, enjoy legal representation by our professional and competent legal team in matters relating to their employment, in the:

- Labour Court;
- High Court;
- Labour Appeal Court;
- Supreme Court of Appeal; and
- Constitutional Court.

This benefit is offered without any limitation to the costs involved, however, it is only available to the members whose matters were handled by IPUSA from inception of the dispute, or handled by IPUSA in the lower forums, and have decent prospects of success as determined by IPUSA's legal team.

## CRIMINAL LAW MATTERS

- Representation in criminal matters;
- Bail applications, including payment of bail for a member in the amount not exceeding R10 000.00;
- Appeals and Reviews.

## CIVIL LAW MATTERS

- Representation in civil proceedings instituted against the member;
- Institution of unlawful arrest proceedings on behalf of the member;
- Representation of the members in contractual disputes;
- Institution of personal injury action on behalf of the member i.e., medical negligence, RAF etc.;
- Vetting and reviewing of contracts entered into by the member, and provision of advice relating thereto.
